

Eco Absorbent Technologies, Inc. Limited Warranty

Eco Absorbent Technologies, Inc., A California Corporation. (“Eco Absorb”), warrants that its products will be free from defects in materials and workmanship for a period of 12 months from the date of purchase by the original purchaser (the “Warranty Period”), if the product has been properly used, stored and shipped. With respect to any product found by you to be defective, Eco Absorb will, during the Warranty Period and at its sole option, promptly repair the defective product without charge, issue a refund for such defective product equal to the price paid by you, or replace the product.

In the event Eco Absorb authorizes in advance that defective product be returned under a warranty claim, in such event Eco Absorb will provide shipping services pre-paid for shipments from the customer to Eco Absorb as well as for shipment of replacement goods to the customer.

To obtain warranty service, it is a requirement that Eco Absorb first provide Return Merchandise Authorization number. When returning any product, the shipment must include your name, address, Return Merchandise Authorization number, a check or money order in the amount of return shipping and handling, proof of purchase, a description of the defect and the date the product was purchased. Any product that is repaired or replaced under this warranty shall be warranted for either 90 days or the remainder of the applicable Warranty Period, which ever period is longer.

This warranty is limited to the original retail purchaser and is not transferable. This warranty may not be modified without prior written authorization by Eco Absorb.

ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, ARE WAIVED. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF.
